- Latest certified or audited financial statements, i.e. Balance sheet and income statements; or your annual report to Shareholders; or similar information on the financial reliability of your company (if you intend to be considered for awards amounting to €250,000 or more).
- 3. Banking information including Bank Name, Account Name, SWIFT and BIC codes, Bank Address, Bank Account Number, for payment of invoices.
- 4. General information about your company and the products/services offered.
- 5. Letter of reference from at least three (3) clients to whom your company has provided goods/services over the past 12 months
